5.1. Review Action Items

6. Team Reports

6.1. Executive Team

Scott Ambs reported that the team met Wednesday. A majority of the discussion was on the IMAGIN elections. Additionally, communications with Mike Muskovin has indicated he will be vacating his seat on the board, and his seat will be released to the open elections.

6.2. Conference Team

Andrew Brenner reported that conference planning is progressing well. A full agenda is completed and there will be workshops. ESRI and Jackson County will be presenting on the parcel fabric. Keynote speakers are confirmed, and workshops will be finalized by the end of February. Efforts will now transition to publicity and getting people registered for the conference.

6.3. Education Team

Chad Collins reported there is nothing new to report. If anyone is interested in serving on the team, all are welcome.

Scott Ambs suggested Michael Deuweke is interested in becoming involved.

Maryellen Jansen suggested that an Education event for mid to late September would be good timing.

6.4. Student Paper and Poster Competition Team

Peter Schneider reported that the competition is completed. Seven (7) poster entries and nine (9) paper entries were received. There were some weather related issues. Only one (1) poster presenter was in attendance. The event drew good attendance for professional networking. Five (5) of the seven (7) confirmed paper presentations were in attendance and presented their papers. Results are being posted on the website. The team is reviewing feedback from the competition and is starting to plan for next year. One concept being considered is pairing of the competition with a SEMCOG user group to increase attendance further.

6.5. Professional Recognition

Trudy Galla reported that applications for the awards are completed and will be posted on a website. Applications were going to be due March 15th, but that may be adjusted. Map Gallery is going to be promoted and more recognition for long-term vendors. The team is proposing to hold a silent auction and/or raffle to develop a scholarship fund, with the initial intent to start a scholarship fund.

6.6. Communication Team

Thomas Van Bruggen reported updates on the website redesign and launch, which should occur on Monday or Tuesday of next week. Special thanks go to Mike Henderson who has donated his time to the site redevelopment. Development of a new database for IMGIN and the website will begin soon, at which time incorporation of forms for contact submittals will occur. Thomas is also working on consolidation and development of IMAGIN social media accounts. Banners for marketing are still being developed and a proposal will be ready for the March meeting. Thomas is also sorting through large volumes of historic documentation on IMAGIN and will incorporate that data into the website.

6.7. Statewide Imagery

Scott Ambs reported the team has not met since our last meeting. The State of Michigan users group in early February presented the new State program. There seemed to be a fair amount of interest in the program. Scott met with Jessica Moy and Everett Root after the meeting to discuss the program and Scott indicated that the program is missing the consistency part where partnerships are still required and necessary for the program. For now the team will be waiting until after the spring flight and/or IMAGIN conference to regroup and determine the direction.
