- 6. IMAGIN's COVID-19 (Coronavirus) Responses
 - 6.1. Meetups April 21st Cancellation Discussion
 - 6.1.1.Executive Team proposes cancelation of April meetups. Discussion was held about hosting virtual meetups, but idea was rejected based on short notice and chaotic nature of large group virtual meetings.
 - 6.2. IMAGIN 2020 Conference Cancellation Discussion
 - 6.2.1.MI Stay Home, Stay Safe order extended until May 1.
 - 6.2.2.Executive Team and Maryellen have concerns (logistically and financially) about postponing the conference and then later canceling. If we cancel in April and rebook for a future year, the Radisson will not hold us to any fees for canceling the conference.
 - 6.2.3. Executive Team recommends canceling the 2020 conference in Kalamazoo. Any paid registrations or sponsorships would be refunded. About \$8,500 has been collected to date for the conference.
